RULES AND REGULATIONS

1. Name of the Association : **RIET ALUMNI ASSOCIATION**

2. Office Address : **Door No.85-12-14/31, All Bank Colony, Ward No.40,
Rajahmahendravaram Urban Village,
Rajahmahendravaram Urban Mandal, East Godavari
District, Andhra Pradesh.**

3. ACTIVITIES:

The General Body shall chalk out the policies and programs and the Executive Committee shall make ways and means and put them into effect to fulfill above objects.

4. BUSINESS DIRECTION:

The President of the Association is empowered to give direction regarding the business of the Association

5. MEMBERSHIP:

- a. Any person who studied at RIET Alumni Association at any time after the college was started in 2008 is eligible to be a member of the Association. Membership of the Association shall be an automatic facility extended to all the old students of the College
- b. Every member shall have a single vote.

6. MEMBERSHIP FEE:

Every member shall pay a onetime membership fee of Rs.100 (Rupees one hundred only) on becoming a member.

7. GENERAL BODY MEETING:

- a. General Body meeting of the members of the Association shall be held at least once in a year in the Month of April and not later than three months after the close of the financial year.
- b. Twenty one days notice shall be given to the members of the Association for General body meetings.
- c. Quorum for a General Body meeting shall be 3/5th members and if the said quorum is not present the meeting within half an hour of the meeting time fixed, the members present may adjourn the meeting to a later date and the adjourned meeting shall not require any quorum but only such matters can be taken up at the adjourned meeting as were in the agenda of the original meeting.
- d. The President shall preside over the General Body of the meeting. In the absence of the President, the Secretary shall preside. In the absence of both , the members may choose one among themselves.


PRESIDENT

- e. Following matters shall be dealt with by the General Body:
- i) Passing the annual accounts.
 - ii) Election of new members of Managing Committee
 - iii) Amendment / repeal of the Rules and Regulations by the Association.
 - iv) Any other business with the permission of the chair.
- f. Every member shall have a single vote.. In the event of a tie, the Presiding officer shall exercise his casting vote.
- g. The ultimate authority in all matters relating to the administration of the Association shall vest in General body.

8. MANAGEMENT:

The management of the Association shall be vested in a Committee. The Committee shall consist of

Vice President
Secretary
Joint Secretary
Treasurer
4 E.C. Members

The Principal of RIET Alumni Association shall be the President of the Committee. The Committee shall have authority to make subsidiary bye laws for the day to day administration and management.

9. EXTRA ORDINARY GENERAL BODY MEETING:

An extra ordinary general meeting shall be called for by the Secretary whenever deemed necessary by the Management Committee or if a requirement is given by not less than 5 members of the Association, setting out the purpose for holding a General Body Meeting. If no action is taken by the Secretary, within one month after the receipt of the requisition, requisitionists themselves may hold a meeting after giving 21 days notice of the meeting. The agenda as per the requisition shall be circulated by them.

10. COMMITTEE:

- a. The General Body shall elect a Committee consisting of One President, One Vice President, One Secretary, One Joint Secretary and One Treasurer and Four E.C. Members shall be the Managing Committee.
- b. All members of the Association are eligible to contest for the post in the Committee.
- c. The term of office of elected members of the Committee shall be three years. All outgoing members of the Committee are eligible for re election.
- d. An elected member of the Committee may resign at any time but such resignation shall take effect only from the date of approval by the Committee.
- e. The office bearers and members of the Committee shall be indemnified in respect of any action taken by them in connection with the affairs of the Association in good faith.


PRESIDENT

11. DUTIES OF THE OFFICE BEARERS:

PRESIDENT:

The President shall be the sole authority. He shall have the casting vote in case of tie in the meetings. All transactions of the Society shall be carried out in the name of the President. The person terminates (Suspended by the President) only President had the authority to terminate or suspend. He shall be the constitutional head of the Society. Society correspondence and all type of letters etc., will approved by the President. The President shall be the chief controlling and Supervision Officer of the Society and shall exercise all the powers of the Managing Committee in case of emergency. He will be in best contact with the Society. He shall closely watch the administrative and other work directly affecting the interests of the members and initiate suitable action.

VICE PRESIDENT:

In the absence of the president, the Vice-President shall act as president with the permission of the President. He will assist the president in the activities of the Society.

SECRETARY:

The Secretary shall convene all the meetings of the Society. He shall be responsible for Carrying into effect, the resolutions of the General Body as well as those of the Managing Committee. He will keep the records of the Society with safe and secure. He will prepare the Annual Report of the Society and place it before the president for inspection and then get it approved by the Annual General Body.

The Secretary has the following powers also

- a) To appoint, dismiss suspend or otherwise punish any salaried employees of the Society and to all or any of them furnish security.
- b) To accept the resignation of members.
- c) To sanction all the contingent expenditures of the Society.
- d) To supervise the punctual payments of fees etc.,
- e) To take policy decisions from time to time in order to create better facilities to the members and better amenities to staff and members.
- f) To take such suitable steps as and when necessary to augment the financial and economic positions of the Society and for the benefit of members and staff.
- g) To make such rules for the internal management of the Society as it may think fit, subject to the confirmation of the General Body.
- h) Every major expense shall be incurred only by the President with the previous sanction of the Managing Committee.
- i) To shift the location of Office and appoint sub-Committee whenever it is felt necessary.
- j) To transact any other matter for the benefit of the society.

JOINT SECRETARY:

He shall carry out instructions of the Secretary from time to time and assist him in all his duties and in the absence of the Secretary, he will exercise or carry out the powers and duties of the Secretary.


PRESIDENT

TREASURER:

He will maintain proper accounts of the Society. He will keep the funds of the Society with the Banks, Post Offices, Societies, as per the directions of the President and secretary. He shall be entitled to collect the funds, subscriptions etc., for the society. When withdrawing any amount from the Bank, Post Office for Society the cheque shall be signed by President and Secretary.

COMMITTEE MEMBERS:

They will attend to the affairs of the society as per the directions of the Managing Committee. They will do other works relating to the Society and strive for the development of the Society.

11. POWERS AND FUNCTIONS OF THE COMMITTEE:

- a. The Committee shall have all such powers which are necessary for the conduct of the affairs of the Association. The President of the Committee shall be responsible for the efficient management of the Association.
- b. The Secretary shall be responsible for executive administration of the Association subject to the control of the Committee. He shall be responsible for convening the meetings giving due notices together with the agenda and shall keep accurate minutes of the meetings which shall be confirmed at the next meeting.
- c. The Treasurer shall be responsible for safe guarding the records and properties of the Association including the funds. He shall issue receipts for cash and cheques received and shall maintain proper payment vouchers for the day to day expenses. Treasurer shall be responsible for the preparing the accounts and getting them audited.

12. BANK ACCOUNTS

Bank accounts may be opened in any Nationalised Bank or banks in the name of the Association as may be decided by the Committee. The bank account shall be operated upon jointly by the Secretary and the President signing on behalf of the Association.

13. INCOME TAX EXEMPTION :

To approach Income Tax authorities of Commission rate and state authorities to apply for Income Tax exemption 12A, 80-G (5) (VI), 35AC, 35I&II for receiving donations which are exempted from income Tax.

13. ACCOUNTS

The accounts of the Association shall be audited by a Chartered accountant appointed by the General body on the expiry of the financial year. The financial year of the Association shall be from the 1st April of a year to 31st March of the following year. The first financial year will be from the date of formation to 31st March 2012.

14. DISSOLUTION










The General Body may at any time by a Special resolution decide upon the dissolution of the Association. On dissolution of the Association if there remains after satisfaction of all assets and liabilities, any property what so ever, the same shall not be paid to the members of the Association or any of them but shall be given to some other society with similar objects as determined by the votes of not less than three fourths of members or proxies present at the time of dissolution.

3. ACTIVITIES:

The General Body shall chalk out the policies and programs and the Executive Committee shall make ways and means and put them into effect to fulfill above objects.

4. BUSINESS DIRECTION:

The President of the Association is empowered to give direction regarding the business of the Association

5. MEMBERSHIP:

- a. Any person who studied at RIET Alumni Association at any time after the college was started in 2008 is eligible to be a member of the Association. Membership of the Association shall be an automatic facility extended to all the old students of the College
- b. Every member shall have a single vote.


6. MEMBERSHIP FEE:

Every member shall pay a onetime membership fee of Rs.100 (Rupees one hundred only) on becoming a member.

7. GENERAL BODY MEETING:

- a. General Body meeting of the members of the Association shall be held at least once in a year in the Month of April and not later than three months after the close of the financial year.
- b. Twenty one days notice shall be given to the members of the Association for General body meetings.
- c. Quorum for a General Body meeting shall be 3/5th members and if the said quorum is not present the meeting within half an hour of the meeting time fixed, the members present may adjourn the meeting to a later date and the adjourned meeting shall not require any quorum but only such matters can be taken up at the adjourned meeting as were in the agenda of the original meeting.
- d. The President shall preside over the General Body of the meeting. In the absence of the President, the Secretary shall preside. In the absence of both , the members may choose one among themselves.

9. EXTRA ORDINARY GENERAL BODY MEETING:

An extra ordinary general meeting shall be called for by the Secretary whenever deemed necessary by the Management Committee or if a requirement is given by not less than 5 members of the Association, setting out the purpose for holding a General Body Meeting. If no action is taken by the Secretary, within one month after the receipt of the requisition, requisitionists themselves may hold a meeting after giving 21 days notice of the meeting. The agenda as per the requisition shall be circulated by them.

10. COMMITTEE:

- a. The General Body shall elect a Committee consisting of One President, One Vice President, One Secretary, One Joint Secretary and One Treasurer and Four E.C. Members shall be the Managing Committee.
- b. All members of the Association are eligible to contest for the post in the Committee.
- c. The term of office of elected members of the Committee shall be three years. All outgoing members of the Committee are eligible for re election.
- d. An elected member of the Committee may resign at any time but such resignation shall take effect only from the date of approval by the Committee.
- e. The office bearers and members of the Committee shall be indemnified in respect of any action taken by them in connection with the affairs of the Association in good faith.

11. DUTIES OF THE OFFICE BEARERS:

PRESIDENT:

The President shall be the sole authority. He shall have the casting vote in case of tie in the meetings. All transactions of the Society shall be carried out in the name of the President. The person terminates (Suspended by the President) only President had the authority to terminate or suspend. He shall be the constitutional head of the Society. Society correspondence and all type of letters etc., will approved by the President. The President shall be the chief controlling and Supervision Officer of the Society and shall exercise all the powers of the Managing Committee in case of emergency. He will be in best contact with the Society. He shall closely watch the administrative and other work directly affecting the interests of the members and initiate suitable action.

VICE PRESIDENT:

In the absence of the president, the Vice-President shall act as president with the permission of the President. He will assist the president in the activities of the Society.

SECRETARY:

The Secretary shall convene all the meetings of the Society. He shall be responsible for Carrying into effect, the resolutions of the General Body as well as those of the Managing Committee. He will keep the records of the Society with safe and secure. He will prepare the Annual Report of the Society and place it before the president for inspection and then get it approved by the Annual General Body.

The Secretary has the following powers also

- a) To appoint, dismiss suspend or otherwise punish any salaried employees of the Society and to all or any of them furnish security.
- b) To accept the resignation of members.
- c) To sanction all the contingent expenditures of the Society.
- d) To supervise the punctual payments of fees etc.,
- e) To take policy decisions from time to time in order to create better facilities to the members and better amenities to staff and members.
- f) To take such suitable steps as and when necessary to augment the financial and economic positions of the Society and for the benefit of members and staff.
- g) To make such rules for the internal management of the Society as it may think fit, subject to the confirmation of the General Body.
- h) Every major expense shall be incurred only by the President with the previous sanction of the Managing Committee.
- i) To shift the location of Office and appoint sub-Committee whenever it is felt necessary.
- j) To transact any other matter for the benefit of the society.

JOINT SECRETARY:

He shall carry out instructions of the Secretary from time to time and assist him in all his duties and in the absence of the Secretary, he will exercise or carry out the powers and duties of the Secretary.

TREASURER:

He will maintain proper accounts of the Society. He will keep the funds of the Society with the Banks, Post Offices, Societies, as per the directions of the President and secretary. He shall be entitled to collect the funds, subscriptions etc., for the society. When withdrawing any amount from the Bank, Post Office for Society the cheque shall be signed by President and Secretary.

COMMITTEE MEMBERS:

They will attend to the affairs of the society as per the directions of the Managing Committee. They will do other works relating to the Society and strive for the development of the Society.

11. POWERS AND FUNCTIONS OF THE COMMITTEE:

- a. The Committee shall have all such powers which are necessary for the conduct of the affairs of the Association. The President of the Committee shall be responsible for the efficient management of the Association.
- b. The Secretary shall be responsible for executive administration of the Association subject to the control of the Committee. He shall be responsible for convening the meetings giving due notices together with the agenda and shall keep accurate minutes of the meetings which shall be confirmed at the next meeting.
- c. The Treasurer shall be responsible for safe guarding the records and properties of the Association including the funds. He shall issue receipts for cash and cheques received and shall maintain proper payment vouchers for the day to day expenses. Treasurer shall be responsible for the preparing the accounts and getting them audited.

12. BANK ACCOUNTS

Bank accounts may be opened in any Nationalised Bank or banks in the name of the Association as may be decided by the Committee. The bank account shall be operated upon jointly by the Secretary and the President signing on behalf of the Association.

13. INCOME TAX EXEMPTION :

To approach Income Tax authorities of Commission rate and state authorities to apply for Income Tax exemption 12A, 80-G (5) (VI), 35AC, 35I&II for receiving donations which are exempted from income Tax.

13. ACCOUNTS

The accounts of the Association shall be audited by a Chartered accountant appointed by the General body on the expiry of the financial year. The financial year of the Association shall be from the 1st April of a year to 31st March of the following year. The first financial year will be from the date of formation to 31st March 2012.

14. DISSOLUTION

The General Body may at any time by a Special resolution decide upon the dissolution of the Association. On dissolution of the Association if there remains after satisfaction of all assets and liabilities, any property what so ever, the same shall not be paid to the members of the Association or any of them but shall be given to some other society with similar objects as determined by the votes of not less than three fourths of members or proxies present at the time of dissolution.










